DETAILS

On 07/30/10 at about 1357 hours, I was dispatched to 2241 Park Pl (Metalast International) reference a bomb threat report. Upon my arrival in the area I met with David Semas who told me the following.

David stated he was at Adele's in Carson City having lunch when he was approached by a waitress named Kristen Dru. Kristen told David the restaurant received a telephone call stating something to the effect of "Is David Semas there? Tell him he needs to get back there, there's been an explosion." The call came from telephone number (760) [REDACTED].

David recognized the telephone number and told me the telephone call came from Ken [REDACTED] a former business partner with whom he has an ongoing conflict.

I contacted Ken at the telephone number David gave me. Ken stated he was at his home in Rancho Mirage mopping his floor. I told Ken why I was calling. David told me he did not make the phone call. Ken went on to say the telephone number on which I contacted him, could be used by a number of people, David included. David later denied this claim.

Deputy Hicks met with David and walked through David's business to look for unusual items. After the search, David determined there was nothing out of place.

David told me he wanted to prosecute Ken for making a bomb threat.

Based on the fact the call was informational in nature rather than threatening, the fact that there are locations of Metalast nationwide and the fact Ken denied making the telephone call I did not believe the circumstance does not fit the criteria for a bomb threat as defined by Nevada Revised Statute.
