The Court clarifies with counsel which parties they represent in this action. The Court notes there is an outstanding issue concerning a Rule 4(m) dismissal of defendant, Dubois Chemicals, Inc. Mr. Lazo advises the Court that plaintiff intends to reinstate Electroplating Consultants International and Broco Products, Inc., as named defendants in this case.

The Court notes that the current outstanding motions in this case are:

#86 - Motion to Intervene filed by Chemeon Surface Technology, LLC;

#87 - Motion to dismiss or, in the alternative, to stay filed by defendants Chemetall US, Inc., BASF Corporation, Qualichem, Inc., John Schneider & Associates, Inc., Ronatec C2C, Inc., Southern Industrial Chemicals, Inc., and proposed intervenor Chemeon Surface Technology, LLC;

> **#89** - Motion for attorneys fees and costs by defendants Chemetall US, Inc., BASF Corporation, QualiChem, Inc., John Schneider & Associates, Inc., Broco Products, Inc., Ronatec C2C, Inc., Electroplating Consultants International, Inc., Southern Industrial Chemicals, Inc., and proposed intervenor Chemeon Surface Technology, LLC;

The Court finds it will STAY this case in its entirety pending the outcome of the *Chemeon Surface Technology, LLC v. Metalast International, Inc., et al.*, case no. 3:15-CV-0294-CBC.

Therefore, the Court finds the motion to intervene (ECF No 86) is DENIED without prejudice; the motion to dismiss (ECF No. 87) is DENIED without prejudice; the motion to stay case (ECF No. 88) is GRANTED; the motion for attorneys fees and costs (ECF No. 89) is DENIED without prejudice; and the motions to dismiss or in alternative, to stay (ECF Nos. 91 and 133) are GRANTED in part and DENIED in part. The motions (ECF Nos. 91 and 133) are DENIED as to the motions to dismiss and are GRANTED as to the motions to stay. And, the joinder in pending motion for attorneys' fees and costs (ECF No. 142) is DENIED without prejudice.

Mr. Boyle advises the Court that the summons returned executed as to Dubois Chemicals, Inc., was filed on April 29, 2019 (ECF No. 127) and inquires whether a default for failure to respond shall be entered. The Court advises that since the case is stayed, this issue can be readdressed once the stay is lifted.

The Court admonishes counsel that when the stay is lifted in this case, the Court will expect that counsel behave in an appropriate, cooperative, professional manner towards one
